### **Potential Project Evaluation Criteria for Regional Projects**

- Area Impacted
  - Does the project address needs in an isolated area of the region or the entire region?
- Sectors Impacted
  - Does the project cross sectors?
- Relationship to regional goals and opportunities
  - Does the project help to accomplish any goals or opportunities? If so, how many?
- Project readiness/timeline
  - How quickly can the project be initiated?
  - Will the project be completed by September 30, 2019?
    - This is a requirement of the RPI Boilerplate
- Can the project be completed organizations prescribed in the RPI Boilerplate?
  - o Regional Planning Commissions
  - Economic Development Commissions
  - Metropolitan Area Councils
  - Metropolitan Planning Organizations
- Investment value
  - Does the project offer a good value or impact for the amount requested?

#### From the Boilerplate:

(10) Unexpended funds appropriated in part 1 for the regional prosperity initiative are designated as work project appropriations, and any unencumbered or unallotted funds shall not lapse at the end of the fiscal year and shall be available for expenditure for regional prosperity initiative projects under this section until the projects have been completed. The following is in compliance with section 451a of the management and budget act, 1984 PA 431, MCL 18.1451a:

- (a) The purpose of the projects is to provide incentive-based grants to recipients under this section.
- (b) The projects will be accomplished by grants to qualified regional planning organizations.
- (c) The total estimated cost of all projects is \$2,500,000.00.
- (d) The estimated completion date is September 30, 2019.

### **INFRASTRUCTURE**

### Encourage expansion and improvement of regional infrastructure

#### Transportation of Goods

- Support regionally impactful infrastructure opportunities for the movement of freight (e.g., support 2nd bridge in Detroit, completion of US 31)
- Intermodal freight transportation (e.g., reliever port for Chicago and Detroit)
- Promote maintenance and improvement of the freeway system and connecting roads
- Promote maintenance and improvement of state and local roads
- Encourage aviation to better support business
- Take advantage of our existing water infrastructure along the Lake Michigan shoreline for the transportation of freight (e.g., freight harbors on Lake Michigan)

### 2. Transportation of People

- Promote maintenance and improvement of the existing freeway system and connecting roads
- Encourage passenger rail as a viable transportation option
- Encourage aviation to better support passenger transportation
- Promote coordination of regional bus transportation

### . Communication

- Promote region-wide access to telecommunications (broadband, cellular)
- Encourage improved speed and quality of telecommunications infrastructure

- Promote competitive cost of energy
- Encourage increased access and production
- Promote diversification of energy portfolio (e.g., creation of micro grids)

### **RPI STRATEGIES** Advance regional communication and collaboration

### 1. Further RPI organizational development

- Establish bylaws
- Examine membership and structure
- Connect sectors via communication, collaboration, and information sharing
- Establish RPI as clearinghouse (network versus an extra step)
- Create regional brand, identity, and image
- Establish criteria for addressing policy issues

## Encourage collaboration among public and nonprofit sectors

- RPI develops or replicates organizational collaboration models for Region 8 to meet needs in a cost-efficient way
- Develop a platform for regular information sharing among the five sectors (learn what others are doing; process for regular information sharing meetings)
- Encourage coordinated strategic asset management across all seven counties
- Explore tribal strategies
- Collaboration on state and federal grants and projects to ensure projects are shovel-ready (e.g., letters of support)
- Encourage emergency management at a regional level

## Strengthen the interface between the Regional Prosperity Plan and local plans

- RPI develops a "template" for creating plans that fit within the regional strategy
- Alignment with state and federal agencies to inform them about RPI goals
- Encourage individual municipal strategies are tied to the regional prosperity plan (including planning)

  - a. This section outlines who members of the committee are and how they are chosen
- 5. Duties and Responsibilities
  - a. This section outlines what is expected of committee members
- 6. Compensation
  - a. This section governs how board members are compensated
- 7. Officers, Elections, Vacancies, Terms
  - a. This section outlines if the committee will have officers, how they are chosen, and the amount of time they serve
- 8. Personnel
  - a. This section outlines the roles of any staff
- 9. Meetings
  - a. This section outlines:
    - i. When and where are the meetings held
    - ii. What constitutes a quorum
    - iii. If special meetings are allowed and how they are called
- 10. Financial Considerations
  - a. This section outlines the means by which this group is funded
    - i. Just RPI grant? Should it pursue other funding?
- 11. Subcommittees
  - a. Will this group have sub-committees? If so, how are they appointed and what is their purpose?
- 12. Amendments
  - a. How are amendments to the bylaws made?
