Approval of the November 12, 2015 Minutes

There were no corrections to the minutes of the previous sub-task force meeting.

MOTION by McBride, SUPPORT by Minkus, ***“to approve the minutes of the January 26, 2018 Kalamazoo County Local Rural Task Force Meeting.”*** Motion approved.

Review of Projects for Fiscal Years 2019 - 2020.

Changes to projects for fiscal years 2019 and 2020 were discussed.

2019

MOTION by Minkus, SUPPORT by McBride ***“to approve adding \$103,474 in STL and \$25,869 in CTF to Metro project number 130079; and eliminating EDD funding and reducing local cost to \$122,524 for a total project cost of \$550,215 for the Road Commission D Avenue project.”*** Motion approved.

2020

MOTION by Minkus, SUPPORT by McBride ***“to approve adding \$105,370 in STL, eliminating EDD funding and reducing local cost to \$1,150,757 for a total of \$1,700,000 for the Road Commission U Avenue project, Job Number 130143.”*** Motion approved.

Call for Projects for Fiscal Years 2020 – 2023

Changes to 2020 having already been approved, projects for 2021 – 2023 were discussed

2021

MOTION by Minkus, SUPPORT by McBride, ***“to approve a project on R Avenue, 36th Street to the east county line using \$541,000 in STL and \$236,967 in EDD and \$122,033 local cost for a total project cost of \$900,000; and to approve a project for the purchase of up to 3 vans for Kalamazoo Metro using \$103,000 in STL and \$25,750 in CTF funding for a total of \$128,750.”*** Motion approved.

2022

MOTION by Minkus, SUPPORT by McBride, ***“to approve a project on S Avenue, 29th Street to 34th Street using \$552,000 in STL and \$488,000 in local cost for a total of \$1,040,000; and to approve a project for the purchase of up to 3 vans for Kalamazoo Metro using \$105,000 in STL and \$26,250 in CTF funding for a total of \$131,250.”*** Motion approved.

2023

MOTION by Minkus, SUPPORT by McBride, ***“to approve a project on 36th Street, T Avenue to PQ Avenue, using \$525,000 in STL and \$157,978 in EDD for a total of \$682,978; and to approve a project for the purchase of up to 2 busses for Kalamazoo Metro using \$145,000 in STL and \$36,250 in CTF funding for a total of \$181,250.”*** Motion approved.

Illustrative

MOTION by Minkus, SUPPORT by McBride, ***“to approve placing a project on the illustrative list for a countywide preventative maintenance project using \$80,000 in STL and \$20,000 in local funding.”***
Motion Approved

MOTION by McBride, SUPPORT by Minkus, ***“to approve placing a project on the illustrative list for the purchase of up to 5 vans using \$160,000 in STL and \$40,000 in CTF funding.”*** Motion approved.
