## 2026 - 2029 Call for Projects.

In response to concerns expressed by Balog regarding the history of funding for Transit, Myland said that he had contacted Fred Featherly at MDOT. Featherly indicated that federal funding has been flexed to Transit for the last two fiscal years. In addition, SJCRC is programmed to receive federal funding of \$84,000 for vehicle replacement in fiscal years 2025 and 2026 through the Rural Task Force program. Balog said he would contact Featherly to find out how to go forward.

It was agreed that since 2026 is already programmed discussion would involve only Fiscal Years 2027 – 2029. Agency representatives put forward proposed projects for consideration. Once all projects were tallied, several fiscal years were overprogrammed. Discussion ensued of how to structure proposed project fiscal years and budgets to bring the budget into fiscal constraint. Consideration included making one Transit project illustrative.
